#### "Occupation before completion" Benefit (Only applicable to the Purchaser who selects Terms of Payment (Z1) or (Z2) under paragraph (4)(i) above)

The Purchaser shall, within 60 days after the date of signing of the preliminary agreement for sale and purchase, submit to the Vendor a duly signed application form for "Early Possession Benefit" together with a copy of the stamp certificate of the Formal Agreement for Sale and Purchase to prove that the stamp duty on the Formal Agreement for Sale and Purchase has been duly paid and execute a licence agreement in the form prescribed by the Vendor's Solicitors without amendment in respect of the residential property he purchased with the following main terms and conditions:

- (i) The Purchaser shall have already paid 10% of the Purchase Price.
- (ii) The licence period shall commence from the day designated by the Vendor in the licence agreement until the completion date as stipulated in the Formal Agreement for Sale and Purchase, or if completion takes place earlier, until the date on which completion takes place.
- (iii) The Purchaser shall be responsible to pay for the stamp duty adjudication fee and stamp duty (if any) on the licence agreement, the legal costs and disbursements for the preparation and execution of the licence agreement and the management fees, government rates and rents and all other outgoings, etc. of the residential property during the licence period.
