Batch A 第A批次

Subject to the provisions set out in "Other matters", first come first served. The Vendor does not accept any person having queued up before the Time of the Sale on the date concerned.

Procedures for Batch A

Persons interested in purchasing any of the specified residential properties that will be offered to be sold in Batch A ("Batch A Purchaser") must follow the following procedures.

1. Batch A Purchaser must submit the following:

- (a) Relevant number(s) of cashier order(s). The number of cashier order(s) shall be equal to the number of specified residential property(ies) to be purchased. Each cashier order shall be in the amount of HK\$100,000 and made payable to "WONG AND CHAN". If the Batch A Purchaser has successfully purchased any specified residential property(ies), the said cashier order(s) will be used as part payment of the preliminary deposit(s) for the purchase of the specified residential property(ies) and the balance to be paid by cheque(s). The Batch A Purchaser must bring along blank cheque(s) for payment of balance of preliminary deposit(s).

Card(s)/Passport(s) or (if applicable) copy of Business Registration Certificate(s) and documents filed with the Companies Registry showing the current list of director(s) and secretary.

The Vendor has absolute right to change the closing date and/or time of the tender in respect of all or any of the specified residential properties from time to time by amending and/or issuing Sales Arrangements.
